Attention Wyoming Medicaid Durable Medical Oxygen Suppliers

Effective January 1, 2018, the Wyoming Department of Health, Medicaid program, was required to comply with the Consolidated Appropriations Act of 2016 (Section 503) and the 21st Century Cures Act (Section 5002). This requirement limits the federal Medicaid reimbursement amount available to states for DME to the Medicare payment rates.

As a result of the requirements, Wyoming Medicaid must reimburse CMS anything above the DME Medicare rate which is generated by the Medicare's Pricing, Data Analysis and Coding (PDAC) contractor and includes Medicare utilization for those same codes.

A review of rates paid in other rural states, and Medicare rates from the past three years, indicates that Wyoming Medicaid payment rates for oxygen are the highest in the region, and in some instances, up to three times higher.

Due to this analysis, Wyoming Medicaid will be decreasing oxygen rates over the next two years to comply with federal requirements and Medicare rates, while still providing access to care for clients. The following codes will be adjusted and will become effective May 1, 2021:
